#### **SCOPE OF WORK:-**

The rates quoted should include charges for Liaisoning, Documentation processing / Procuring, Loading at Coal Fields of Singareni Colleries Co., to DAMULand other charges as may be incurred to transport the (consignments) Coal from the Pit Heads to the Destination (ie., Dharwad Milk Union/DAMUL) and in connection with Liaisoning and documentation/ Processing/ Procuring and also to cover any other loss to be met out as indicated in the following terms and conditions:

- a) The area of operation of liaisoning and transportation shall be all coal fields of the Singareni Collieries Co.Ltd., Hyderabad situated in different area and approximately 800 KM from Dharwad.
- b) The contractor taking up the Liaisoning and Transportation of Coal, shall be responsible for pursuing, followup of allotment of coal by Singareni Collieries Co.Ltd., and procurement of good quality coal and movement of the Trucks/ Transportation of coal till destination as would be indicated by us.
- c) On issue of the recommendation by the Additional Director, Industries & commerce Department of Karnataka on Singareni Collieries Co.,Ltd., the Liaisoning Agent has to followup and obtain allotments on a best colleries of Singareni Coal Field.
- d) The contractor is the responsible to deposit the coal cost and obtain the permit on good coal mines against our advance payment which has been sent to contractor or M/s SCCL Hyderabad by DD / RTGS in favour of M/s SCCL Hyderabad within due date. Road Release Order / Programme at Colliery and arrange despatch accordingly and ensure to supply within 30 days on allotment. Otherwise information should be given in writing for the delay with reasons, which is acceptable otherwise any loss on account of non arrangement of supply the same will be recovered from the contractor.

- e) Effective supervision has to be made while loading the coal for quality and quantity at the Colliery level and arrange to send the coal bills separately.
- f) The unloading of the trucks will be done by the DAMUL Dharwad at its cost.
- g) The approximate quantity now being required is 525 MTs per month or 6300Mts per annum and the same is likely to be increased or decreased depending upon the consumption.
- h) This contract shall be in force for a period of two years (BRC) from the date of issue of Final Work Order or such shorter period as may be determined by DAMUL. DAMUL also reserves the right either to extend the contract for a period of 3 months after expiring the period of two years.
- i) In case of increase / decrease in fuel prices by the State / Central Government of India, the transport rates paid to the contractor will also be revised on pro-rata basis, considering 4KM/Ltr of the diesel during contract period.

# **GENERAL TERMS & CONDITIONS:-**

- 1. The tenderer should be furnished EMD of Rs.50,000/- through any one of e-payment as specified in e-procurement portal.
- 2. The contractor shall furnish Rs.2.00 lakhs (Rupees Two Lakhs only) by cash and Rs.6.00 lakhs (Rupees Six lakhs only) by Bank Guarantee for a period of 27 months from the date of the contract period as a Security Deposit for due performance of the contract. The Bank guarantee and agreement shall be provided on receipt of our letter within 15 days on receipt of intimation in writing.
- 3. The successful tenderer should enter into an agreement with the DAMULDharwad for proper performance of the contract on a non judical stamp paper of Rs.200/-.
- 4. The tenderer should not be a Coal Supplier / Dealer/Trader. Such tenders will not be accepted.
- 5. The contractor shall also discharge as the Liaison and Transport Contractor for Dharwad Milk Union, hereby agrees that it is their responsibility to procure the best quality coal from the Collieries.
- 6. No Transit loss or shortage will be allowed. Shortage if any, will be recovered from the contractor at cost of the coal which shall include rate charged by collieries + Liaisoning and Transportation charges paid to the Contractor.
- 7. The contractor shall be held responsible for any malpractice ie., shortage of coal, inferior quality, more stone, slate and dust etc., and maximum dust percent allowed is 10%. If it is more which will be recovered from contractor. Slate content also to be maintained.

- 8. If the coal despatched from Colliery in the trucks lost or mis delivered, the entire cost of the coal will be recovered from the contractor.
- 9. The cost of coal, lost or damaged or pilferred during transit and / or cost of coal, not delivered or short delivered at the destination shall have to be borne by Contractor. The ultimate authority to assess the damage / losses shall be Managing Director, DAMUL or his authorised representative and the contractor agree that no claims or suits of any kind will be filed in this regard.
- 10. The contractor should strictly adhere to the schedule for transportation of coal issued by M/s SCCL Hyderabad from time to time.
- 11. The contractor shall make good to the DAMUL any loss which it may suffer owing to the contractor's failure to carryout the work entrusted to him under this contract.
- 12. The decision of the Managing Director, DAMUL or his authorised representative shall be final and binding on the contractor on all matters or disputes arising out or in connection with the contract.
- 13. If the contractor fails to carryout the work assigned to him under the contract or does not carryout the entire work or part thereof, within the stipulated time or commits any breach of the terms and conditions of the contract, the DAMUL may at its discretion.
  - a) Cancel the contract or any portion thereof; and / or
