#### Section – I

#### Information Memorandum

#### 1.1 Background

Karnataka Co-operative Milk Producers' Federation Limited (KMF) is the Apex Body in Karnataka representing Dairy Farmers' Co-operatives. It is the second largest cooperative amongst the dairy co-operatives in the country after Amul dealing in Milk and Milk products. In South India it stands first in terms of procurement as well as sales. One of the core functions of the Federation is marketing of Milk and Milk Products. The Brand "Nandini" is the household name for Pure and Fresh Milk and Milk Products.

Presently, KMF is procuring on an average 82 lakhs ltrs. /day and is being disposed off in different forms viz., market milk, curd, butter, ghee, powder and other products. Further, it is engaged in manufacture of Nandini cattle feed in 7 of their total units to cater to the need of milk producers. KMF proposes to establish chocolate manufacturing unit and other facilities to strengthen its capacity.

#### **1.3** Expression of Interest (EOI)

#### Section – II

#### **Eligibility Criteria**

Applicants shall satisfy all the following minimum eligibility criteria for short-listing:

- (i) Should be a company / firm /individual.
- (ii) In case of foreign company, they should have Indian subsidiary
- (iii) In case of company / firm, should have registered under relevant Acts in India and should be in existence for at least three years.
- (iv) In case of individuals, they should be Indian citizen.
- 2.1 Process of short-listing

Filled – in format submitted by applicants before the last date for submission will be scrutinized for short-listing based on conformity with eligibility criteria. The eligible applicants may be required to furnish the documents on their project experience, capacity and capability, financial standing. Based on satisfying eligibility criteria, applicants will be selected for short-listing.

- 2.2 Right to accept or reject any of the EOIs
  - (1) KMF reserves the right to accept or reject any EOI and to annual the short-listingprocess, at any time without any liability or any obligation for such acceptance, rejection or annulment, without assigning any reason.
